11. Motion to Approve Funds for Canton Valley Tenant Association

Mr. Bushman noted that the association will need to provide their accounting of their 2019 funds before they receive this payment.

Mr. Bushman spoke about the Coronavirus situation. He informed the board that maintenance employees are working on vacant units because they are not doing routine work orders due to the coronavirus. There are 15 units that need rehab (asbestos units are not in this total). 5 units were leased up this month at Green Acres as per Genesis. There is an increase in \$0 income at this time too.

Mr. Bushman spoke about the NOFA Creative Place Making Grant due April 29, 2020. He would like to have art with physical improvements for Durkin on Blossom St. The intention is to beautify the area for the residents. The motion will be in the April meeting.

Mr. Bushman also noted that Exeter Street has been converted from a 4 bedroom to a 2 bedroom. He's also made some progress on Pleasant and Prospect St sale and disposition. Linda Byrne asked for clarification on how the properties are disposed of.

Mr. Bushman informed the board that the Resident Service Coordinator DHCD Grant was approved. It is an award of \$30,000 plus \$10,000 for costs. Also, FHA has submitted the Grant for DHCD Gateway Cities Revitalization. Nice job by Linda Byrne and Mary Giannetti. Also, Frances Nolivos and Andrew

Skoog met with a local marijuana company who committed \$300,000 whether the FHA is awarded the grant or not. In reference to the MOD-PHASE Grant for Wallace, this has been on standstill due to the Coronavirus. He also updated the board on several other FISH projects including boilers at Green Acres and the sewer separation. The sewer separation has been at a standstill for over a year. It is progressing now. Gutters and downspouts have been added to the plans. Funding is from HILAPP not formula funds. Irrigation and landscaping should help reroute water with no digging in most basements (only 3 will need digging). The Daniels Heights Parking Lot Expansion Project will begin soon. DHCD has also been notified that FHA would like to begin FISH 097122 the 76 Mechanic St Window Replacement Project. The FISH 097125 Green Acres Replacement of Electrical Panels will be complete next week.
